

The following terms are related to specific Non-Profit Animal Related organizations that have been invited to be a part of the I AM A GOOD DOG project.

1. "Money Barks" – when an individual purchases a Good Dog Block, they are asked to select a non-profit animal organization to receive 10% of the purchase in cash. As a Good Dog Non-Profit, your organization will be on this list. Funds will be forwarded to your organization based on the payment terms of Box-Office Blocks, LLC.
2. "Sponsorship Recipient" - Businesses, individuals and foundations (Sponsors) will purchase Good Dog Blocks that will be donated to your organization. As a Sponsorship Recipient, you agree to distribute the FREE Good Dog Blocks, along with a fun offer, invitation or message from the Sponsor, to your members, volunteers, employees, social network, etc... For every person that builds their FREE Good Dog Block and for any additional blocks they may purchase, your organization will receive 10% of the value in cash. This does not apply to bonus blocks.
3. The FREE Good Blocks, along with the Sponsor offer, will be provided to you in the form of a physical card or an email containing a special code. This will allow you to distribute this fun gift to your supporters easily and quickly.
4. Your organization will be assigned a personal page and given a maximum of 25 Good Dog Blocks that will carry your logo and organizational information. Your organization's name will also appear on the Sponsors and Non-Profits page as well as on each associated Good Dog Block. If after signing up, your organization becomes unwilling or unable to participate, your page will be closed and / or removed and any remaining blocks redistributed to another organization.
5. As a Good Dog Non-Profit, you agree to distribute the FREE Good Dog Blocks within two weeks of receipt and to provide a donation receipt when requested. iamagoooddog.com reserves the right redistribute your blocks to another organization in the event that you are unable or unwilling to distribute them.
6. You have the right to refuse the contribution of any sponsor for any reason.
7. Provided that all Good Dog Blocks on the site are sold, your organization will have the opportunity to receive free memberships to the Behind the Scenes. These memberships will be received and distributed in the same way as the Good Dog Blocks.
8. Provided the feature film "Good Dogs" is completed, your organization will have the opportunity to screen the feature film as a fund-raiser in your city. You will be able to keep 100% of the profits. Once the project enters the phase of *making the movie*, we will post specific terms and conditions related to the screenings. It is not necessary to have participated in the any other phase of this project to qualify as a screening city.
9. By participating, there is no guarantee that you will receive any sponsored blocks and you are free to withdraw your participation at anytime. If you do withdraw, we would ask that you return any undistributed Good Dog Blocks.
10. If you would like your organization to be a Good Dog Non-Profit, please contact us and we will see about adding you on. Please note that we are only taking a limited number of groups for the block phase of the project.
